ADVERTISING SERVICE

Subject to compliance of this Agreement by the Customer, the District Gazette agrees to publish the Advertisement submitted by the Customer to the District Gazette in the Newsletter in accordance with the advertising details set out in Schedule 1. The Customer must submit the Advertisement to the District Gazette before the Advertising Material Deadline in the manner and by the means as set out above. If the Customer does not supply the Advertisement to the District Gazette before the Advertising Material Deadline, the District Gazette may publish in the Newsletter any other advertisement previously submitted by the Customer to the District Gazette for publication in the Newsletter.

ORDER FOR PUBLICATION

Receipt of copy by whatever means (including verbal) shall constitute an order for publication of the advertisement and acceptance of these conditions.

ACCEPTANCE OF ADVERTISEMENT FOR PUBLICATION

The District Gazette has an absolute and unfettered discretion to refuse to publish any or all Advertisements that the Customer submits to the District Gazette if the District Gazette deems them unsuitable for publication. If the District Gazette refuses to publish an Advertisement, the District Gazette will notify the Customer.

CANCELLATION OR VARIATION

The Customer may cancel an Advertisement by written or verbal notice to the District Gazette. Notice of cancellation must be received at least seven (7) days before the Advertising Material Deadline set out in the Production Schedule.
